

Ditka's Sports Dome Haunted House 2009 Actor Contract

The Haunted Mansion and Asylum 13 at Ditka's Sports Dome, in Bolingbrook IL, will again be providing the "Ultimate Scare" and entertainment experience during the month of October 2009. As part of the planning process for the 2009 Haunted House, it is important that we address the relationship and the need for quality actors in the Mansion and Asylum. To that end, this document shall be a contract between the actor and management of the house, that states the terms and conditions of the relationship as follows:

1. _____, has indicated a desire to be an actor in the 2009 Ditka Haunted House and has completed the application (Exhibit B).
2. It is understood that the intended days of operation of the House during October 2009 are shown in Exhibit C.
3. Hours of operation are weekdays and Sundays 6-10pm (or until last customer is through the house), and Fridays and Saturdays 6-11pm (or until last customer is through the house).
4. The actors shall be required to attend one of two "training sessions" prior to the house opening in October to familiarize themselves with the house and responsibilities.
5. The actors are expected to be prompt, ready in costume, make-up, and location by 6pm so that the house may open reasonably on time (within 15 minutes of open).
6. Actors shall be compensated at an hourly rate of \$8/hour
7. To be eligible of compensation, actors will be required to work a minimum of eight (8) nights with (2) of those nights during the last week of the haunt. In the event an actor fails to meet these requirements or is a "NO SHOW" during any night of the haunted house, he/she will forfeit any money due to them by the Haunted House.
8. Any actor who works eighty (80%), or higher, of the nights the Haunt is open, shall be eligible for additional "bonus" compensation.
9. The actor has indicated his/her schedule of committed nights to work by a marking of an "X" on the days of the Haunted House.
10. All compensation shall be paid to the actors during the second (2nd) week in November at Ditka's Sports Dome.
11. Both parties agree that this is a commitment and obligation for both to adhere to.
12. By signing this agreement, you are acknowledging all rules and commitments to the Haunted House and management staff during October 2009.
